Pursuant to the CWC's Procedures for Resolutions of Necessity and Eminent Domain, Section 1, this letter is being provided by the Department of Water Resources (DWR) to inform the California Water Commission (Commission) of its intention to proceed with presenting the attached list of Resolutions of Necessity (RON) and request these items be noticed on the Commission's agenda and notice be sent to the landowner of the properties for which the RON is being considered. These RONs are needed in support of the Yolo Bypass Salmonid Habitat and Fish Passage Improvement Project (Big Notch).
