**Subject:** APN Numbers 033-220-060, 033-220-067, 033-011-015, 033-011-004, 042-260-024, 033-440-002, 033-220-068, for which letters have been received from DWR.

APN Numbers 033-440-001, 033-220-054, 033-220-061, 033-220-058, 033-190-036, 033-190-038, for which no letters have yet been received from DWR.

Dear Ms. McCalvin:

The United States Fish and Wildlife Service (USFWS) is in receipt of several letters from Right-of-Way agents with the State of California Department of Water Resources (DWR), concerning the above-referenced APN numbers. In addition, we anticipate DWR will issue letters concerning the parcels identified by APN numbers above, for which letters have not yet been received, concerning additional easement parcels and one conservation bank parcel. The USFWS anticipates that DWR will notify us of prospective flowage through the Yolo Bypass Salmonid Habitat Restoration and Fish Passage Project (Big Notch Project or Project). These letters are or will be directed to the USFWS Realty Office and/or to the Sacramento National

Wildlife Refuge Complex, or to the USFWS Fisheries and Aquatic Conservation Program, and identify that the USFWS holds conservation easements or a beneficial interest in properties over which DWR is proposing to acquire flowage easements. The letters also invite submission of written comments within forty-five (45) days, to include identification of any potential conflicts between the proposed public use and the terms of the USFWS conservation easements. By letter dated February 14, 2022, the USFWS provided its initial comments in response to the DWR notification letters received as of that time, concerning eight properties in which the United States holds conservation easements. These parcels were addressed in the California Water Commission Resolution of Necessity hearings held in April and May of 2022. This letter provides the USFWS' initial response to each of the remaining prospective notice letters that we anticipate DWR will be providing, including those received to date and those anticipated to be forthcoming.

The conservation easements are federally-held real property interests, in which title is held in the name of the United States of America. These easements were obtained by the United States for the purpose of protecting migratory bird habitat, and they are administered as part of the National Wildlife Refuge System. In addition, the USFWS is a third-party beneficiary of a conservation easement to a property containing the Pope Ranch Conservation Bank, providing protection in perpetuity for the giant garter snake, which is listed under the Endangered Species Act as a threatened species.

Please find enclosed a table indicating the USFWS' preliminary assessment of potential properties in which the United States holds conservation or other beneficial interests that may be affected by the Big Notch Project. Because DWR has not yet officially notified the USFWS of all properties that it considers will be affected or outlined the full extent of the anticipated impact to each property, the USFWS at this time cannot complete an assessment of the complete impacts of the proposed flowage of the property; we note, however, that the proposed flowage may impact migratory bird foraging habitat on the easement parcels. At this point, this letter simply provides DWR notice that there are federal land interests that may be affected by this Project and that must be addressed in accordance with federal law.

Please consider this letter as the USFWS' response to any further notification letters that DWR plans to send regarding additional USFWS conservation easement properties or properties in which the USFWS has a beneficial interest.
