Although no formal Commission action will be taken, the Commission offers an opportunity for the public to address the Commission on items of interest that are within the Commission's jurisdiction, but that do not appear on the agenda.

9. Consideration of Action on Resolutions of Necessity for the Yolo Bypass Salmonid Habitat Restoration and Fish Passage Project (Big Notch Project) - AMENDMENTS (Action Items)

On July 13, 2022, the Department of Water Resources (DWR) notified the Commission of its intent to seek Resolutions of Necessity (RONs) for the Big Notch Project in furtherance of a potential eminent domain action against the properties listed below. DWR cannot commence an eminent domain proceeding unless the Commission first adopts a RON (Code of Civil Procedure §§1245.210, 1245.220). At the Commission's September 21, 2022 meeting, DWR presented a report on each property, required by the Commission's Procedures for Resolutions of Necessity and Eminent Domain, (adopted August 17, 2011, revised February 20, 2013) containing information required by Code of Civil Procedure §§1245.230, and 1240.510. On October 19, 2022, the Commission adopted RONs for the properties below. The RONs were missing a required statutory reference. On March 16, 2023, DWR requested the Commission consider adopting these amended RONS. At this meeting, the Commission will consider adopting amended RONs, which will include considering additional information, if any, and determining if there is enough evidence to satisfy Code of Civil Procedure §§1245.230, 1240.510, and 1240.610. The Commission may choose to take action at this meeting. To adopt a RON requires a two-thirds vote of all members, which is a minimum of six votes in favor of the RON regardless of the number of Commission members present.

10. Water Storage Investment Program: Projects Update

Commission staff will provide an update on the progress of projects being considered for funding in the Water Storage Investment Program (WSIP).

11. Water Storage Investment Program: Request to Increase Early Funding Award Amount (Action Item)

In February 2022, the Commission voted to adjust the Maximum Conditional Eligibility Determinations (MCEDs) of all projects in the Water Storage Investment Program (WSIP) to account for inflation. WSIP projects may receive up to 5% of a project's MCED as an early funding award to pay for completion of environmental documentation and permits. The Commission will consider a request from Sites Project Authority, project proponent for the Sites Project, to increase its early funding award amount by \$2.9M so the total early funding award is equal to 5% of its revised MCED, or \$43,769,818.

12. Revisions to Procedures for Resolutions of Necessity and Eminent Domain (Action Item)

California Code of Civil Procedure sections 1245.210 and 1245.220 require DWR to
obtain a Resolution of Necessity from the Commission before proceeding to initiate
court action to obtain property rights from private citizens. The Commission's
"Procedures for Resolutions of Necessity and Eminent Domain" were adopted on August
17, 2011 and revised on February 13, 2013. Commission counsel will present revisions to
the Resolution of Necessity procedures for Commission consideration and potential

13. Long-term Drought: Expert Panel on Desalination

In support of Water Resilience Portfolio Action 26.3, a panel of speakers will present a variety of perspectives on water desalination in California. Representatives from DWR, the Lawrence Berkeley National Laboratory, the City of Santa Barbara, and California Coastkeeper Alliance will provide State agency, academic, practitioner, and environmental perspectives on desalination.
