Oroville Dam Spillway and Feather River Fish Hatchery

This meeting of the California Water Commission will be conducted as an in-person tour of multiple State-operated facilities. Remote participation opportunities are not available for this meeting. Tours will involve moving around the facilities; comfortable clothing and shoes are recommended. All tour locations are ADA accessible. Members of the public are responsible for their own transportation.

7. Oroville Dam Spillways Tour

Department of Water Resources (DWR) staff will lead the Commission on a tour of the Oroville Dam spillways, which were redesigned and reconstructed after they were damaged by erosion in February 2017.
