# 9. Consideration of Regulations for the Model Water Efficient Landscape Ordinance (MWELO) (Action Item)

Staff from the Department of Water Resources (DWR) will seek approval for proposed updates to regulations for the Model Water Efficient Landscape Ordinance (MWELO). On August 16, 2023, the Commission received an informational update on the MWELO. DWR must update the MWELO every three years or release findings that a revision would not be useful or effective in increasing the efficiency of landscape water use or the administration of the MWELO.

# 10. Consideration of Architectural and Engineering Rulemaking (Action Item)

Staff from DWR Division of Engineering will seek approval for proposed amendments to its Architectural and Engineering (A&E) contracting regulations. A&E contracts utilize qualifications-based selection and are not low-bid contracts, allowing DWR to hire highly qualified consultants when needed.

# 11. Water Storage Investment Program: Projects Update

# 12. Strategic Plan Development: Discussion of Key Topics and Goals and Objectives

Commission staff will present the results of the Commissioners' responses to a questionnaire on key topics that help shape the Commission's 2025 strategic plan and share draft goals and objectives for the strategic plan.

# 13. State Water Project Briefing: Strategic Plan Goal One Overview

DWR staff will brief the Commission on the first goal of the State Water Project (SWP) Strategic Plan and will cover topics such as employee safety, emergency preparedness, and safety through physical and cyber security. The briefing will also include an update on the current operations of the SWP, and an overview of the recently released report on the economy of the SWP.

# 14. Update on Sustainable Groundwater Management Act Implementation and Groundwater Trading

DWR staff will provide an update on implementation of the Sustainable Groundwater Management Act (SGMA), including State activities related to the Commission's May 2022 white paper on groundwater trading.

# 15. California Water Plan Update 2023: Presentation of Final Product

DWR staff will update the Commission on the final California Water Plan Update 2023 (Update 2023). The Commission was last briefed on Update 2023 at its April 2023 meeting. The California Water Plan is the State's strategic plan for sustainably managing and developing water resources for current and future generations.
