Speaker: General Manager Murphy provided an overview of the item. Presentation by Assistant General Manager (AGM), Kyle Ochenduszko.

Public Comments:

 Taryn Ravazzini, Los Vaqueros (LV) Reservoir Joint Powers Authority (LV JPA) Executive Director, read a statement on behalf of LV JPA Chair, Anthea Hansen, which stated the LV JPA is willing to continue working with CCWD on the efforts to bring the project to completion.

Board Comments:

- Vice President Martinez stated he has been a proponent of the Los Vaqueros Phase 2 Expansion (LVE) project since his election to the CCWD Board and has since seen the price tag double; stated it is most important to protect the rate payers original investment in LV; and stated although the LV JPA Board has criticized CCWD for moving slowly, there is too much risk for CCWD rate payers to move the project forward.
- O Director Holdaway stated CCWD rate payers are top priority and there is no business case which allows LV to be out of service, for up to 5-years, without a guaranteed backup water supply; stated the project has changed from a regional storage project with a small conveyance intertie to a project largely focused on conveyance; stated the project has become too expensive; and noted she previously withdrew her support for this project when she no longer saw a business case with solutions to bring the project to fruition.
- O Director Young stated she was proud to be part of this effort but expressed reservations for continuing to support the project due to the risk to CCWD rate payers. She stated the money spent on the project is justifiable even though it has led to learning the project is not viable and it would be unconscionable for the Board to continue to barrel through while ignoring the significant issues that have come into play.
- Director Burgh spoke of his 20 years of service on the CCWD Board, noting he was part of the
 creation of the principles; stated the principles are non-negotiable and highlighted the beneficiary
 pays and funding for use of existing facilities principles are key to honoring CCWD's customers
 investment in the original project; and stated the project has become an unbuildable and, more
 importantly, unwise endeavor that cannot be built while protecting the interest of the rate payers.
- Director Burgh stated that although the project was started with the best intentions, the honorable thing to do is to thank the partners and direct staff to develop an approach to terminate CCWD's role in the project.
- Vice President Martinez stated there will be continued discussions on the progress of this project and stated he can already see how successful CCWD has been with regional collaboration.
- President Avila highlighted the importance of LV, the commitment to the ratepayers to upholding the principles, and the good faith efforts placed on this project. He commended staff and the joint partners for their work on the project; stating the regional relationships are pivotal; however, the project is not viable without adoption of the principles and a reliable back up water source.
- President Avila reiterated the consensus of the Board to direct staff to report back with an approach to withdraw from the project.
- General Manager Murphy confirmed she will work with staff and connect with external partners to develop an approach to end CCWD's participation in the LVE project.
- Vice President Martinez emphasized when moving forward to stick to the facts and not let personality conflicts effect decisions.

- John Negrete, CCWD Customer, thanked staff and the Board for their vision and commitment to make these fundamental commitments to the ratepayers. Mr. Negrete stated he is saddened about the challenges, but appreciates the Board sticking to their commitments and encouraged the Board find a way LV can be used regionally.
