



The Groundwater Sustainability Agency (GSA) Forum is a series established by the Department of Water Resources (DWR) to provide a consistent venue for GSA members and interested parties to engage in conversation and exchange ideas around topics related to Groundwater Sustainability Plan (GSP) implementation. The theme of the Spring 2024 Forum focused on *Applications of State Assistance: Leveraging Statewide Airborne Electromagnetic (AEM) Data at the Basin Level to Inform GSP Implementation*. The event included a panel discussion highlighting how GSAs are using AEM data to fill data gaps, inform their hydrogeologic conceptual model, update their groundwater model, and support project implementation. The program also included an opportunity for attendees to share experiences and resources through two breakout sessions, a highlight of upcoming DWR assistance releases, and a preview of the upcoming SGMA 10-year anniversary event.
