The Department of Water Resources anticipates that the State's portion of San Luis Reservoir will be full sometime during the week of January 5, 1998 through January 11, 1998. A large portion of the stored water in San Luis is (1) long-term carryover water previously requested by some contractors under Article 56(c) of the Water Supply Contracts, and (2) undelivered 1997 entitlement water which may qualify for carryover under Article 12(e) of the contracts.

This is to notify contractors with stored carryover water that the reservoir space occupied by that water will soon be needed for 1998 State Water Project operations. Those contractors with stored carryover water should take delivery of that water to meet demands within their service areas or for programs outside their service areas which have been approved by the Department, or they will risk loss of their stored water. Upon the filling of the State's portion of San Luis Reservoir, carryover water will begin to be converted to SWP water at a daily rate equivalent to the Department's ability to theoretically store additional water.

In order to administer and document SWP operations, the Department requires that any contractor wishing to carryover 12(e) water into 1998 and that has not requested such carryover, provide a request to Donald R. Long, Chief of DWR's State Water Project Analysis Office by FAX (916) 653-9628 on or before January 9, 1998. When considering the carryover of 12(e) water, be reminded that a contractor cannot store undelivered 1997 entitlement water and also sell water to the 1998 Turnback Program.

The Department announced establishment of the 1998 Interruptible Water Program on December 30, 1997. Water is anticipated to be available under this Program, although in limited quantities, for the next few weeks.

The Department of Water Resources is increasing the 1998 allocation of entitlement water for long-term State Water Project contractors from 1.62 acre-feet to 2.41 acre-feet. Based on recent precipitation and resultant runoff, SWP supplies are now projected to meet 60 percent of most SWP contractors' Table A entitlements up to their requested amount. A table reflecting the increased 1998 SWP allocation of entitlement water is enclosed.

In making this mid-month adjustment, the Department is allocating water to users as soon as feasible to help contractors plan their operations for 1998. The Department's new approval considered several factors, including the existing storage in SWP conservation reservoirs, a conservative projection of hydrology and water supply expected to develop during the remainder of the 1998-99 water year, SWP operational constraints, and 1998 contractor demands. SWP contractors' Table A for 1998 totals 4.09 MAF, of which 3.34 MAF was requested. As the year's hydrologic and water supply conditions continue to develop, revised allocations may be made.

The Department of Water Resources is offering to interested contractors who have signed the Monterey Amendment, the opportunity to sell allocated 1998 entitlement water through two turn-back water pools. There will be a Pool A and Pool B. The procedures for administering the program are described in Article 56 of the long-term Water Supply Contracts. A participating State Water Project contractor may sell allocated 1998 entitlement water that it will not use within its service area, provided that (1) the contractor has not elected to store project water outside its service area in 1998, and (2) the contractor has not elected to carry over entitlement water from 1997.

To participate in the program either as a seller or buyer, a SWP contractor must agree to the terms and conditions in this notice and attachment, sign and date the attachment, and mail the attachment to Donald R. Long, Chief, State Water Project Analysis Office, Department of Water Resources, Post Office Box 942836, Sacramento, California 94236-0001. Signed and dated attachments must be received by February 15, 1998. Last-minute submittals should be faxed to (916) 653-9628.

1998 Turn-Back Water Pool Program

Criteria

1. The program is available to contractors that have signed the Monterey Amendment. The 1998 turn-back pools are subject to the criteria and provisions included in Article 56 of the long-term Water Supply Contracts.
2. Sales and purchases of turn-back water by participating contractors shall not affect the allocation of entitlement water to contractors in 1998.
3. The Department may limit or delay delivery of turn-back water due to limits on operational capacity in State Water Project facilities or due to changed operational conditions.
4. Delivery priority of turn-back water will be the same as entitlement water (Priority 1) as described in Article 12(f) of the long-term Water Supply Contract, so long as the total amount of project water does not exceed the contractor's 1998 Table A entitlement. Delivery priority of turn-back water when the total amount of project water exceeds the contractor's Table A entitlement, will be the same as interruptible water above a contractor's Table A entitlement (Priority 6).
5. Turn-back water may be stored outside of the purchasing contractor's service area. The location of this storage may be inside or outside of the State Water Project service area, but must be consistent with water rights permits for the State Water Project.

Scheduling and Charges

6. A contractor offering to sell turn-back water in Pool A must notify the Department in writing on or before Sunday, February 15. Since February 15 falls on a Sunday, offers for selling turn-back water can be faxed to the State Water Project Analysis Office at (916) 653-9628. The Department will notify all participating contractors of the availability of water through Pool A on or before February 19.
7. A participating contractor willing to buy turn-back water through Pool A must submit its written request to the Department on or before Sunday, March 1. Since March 1 falls on a Sunday, requests for purchasing turn-back water can be faxed to SWPAO at (916) 653-9628. The price for such water will be \$11.40 for each acre-foot of water purchased (50 percent of the Delta Water Rate).
8. The Department will notify all participating contractors of Pool A sales on or before March 4. For any water that remains unsold in Pool A, the offering contractor may cancel its offer to sell its share of unsold water in writing no later than March 15.
9. A contractor offering to sell turn-back water in Pool B must notify the Department in writing on or before Sunday, March 15. Since March 15 falls on a Sunday, offers for selling turn-back water can be faxed to SWPAO at (916) 653-9628. Pool B water will consist of turn-back water offered after February 15 and on or before March 15, and any unsold water from Pool A which was not canceled by March 15. The Department will notify all participating contractors of the availability of water through Pool B on or before March 19.

10. A participating contractor willing to buy turn-back water through Pool B must submit its written request to the Department on or before Wednesday, April 1. The price for such water will be \$5.70 for each acre-foot of water purchased (25 percent of the Delta Water Rate).
11. The Department will notify all participating contractors of Pool B sales on or before April 3. For any water that remains unsold in Pool B, the offering contractor may cancel its offer to sell its share of unsold water in writing no later than April 14.
12. The Department shall decide on April 15 whether to purchase any portion of unsold Pool B water remaining on that date.
13. A contractor selling or purchasing turn-back pool water will be required to enter into written agreements with the Department.
14. A contractor purchasing turn-back water should submit its revised delivery request to the Department as early as possible after being allocated the turn-back water.
15. The purchasing contractor shall pay the Department the 1998 Transportation Variable Operations, Maintenance, Power, and Replacement Component charges and the Off-Aqueduct Power Facilities Charges for turn-back pool water delivered, as described in Article 56(d)(7).
16. The 1998 turn-back water pool program shall not be a precedent for future programs.

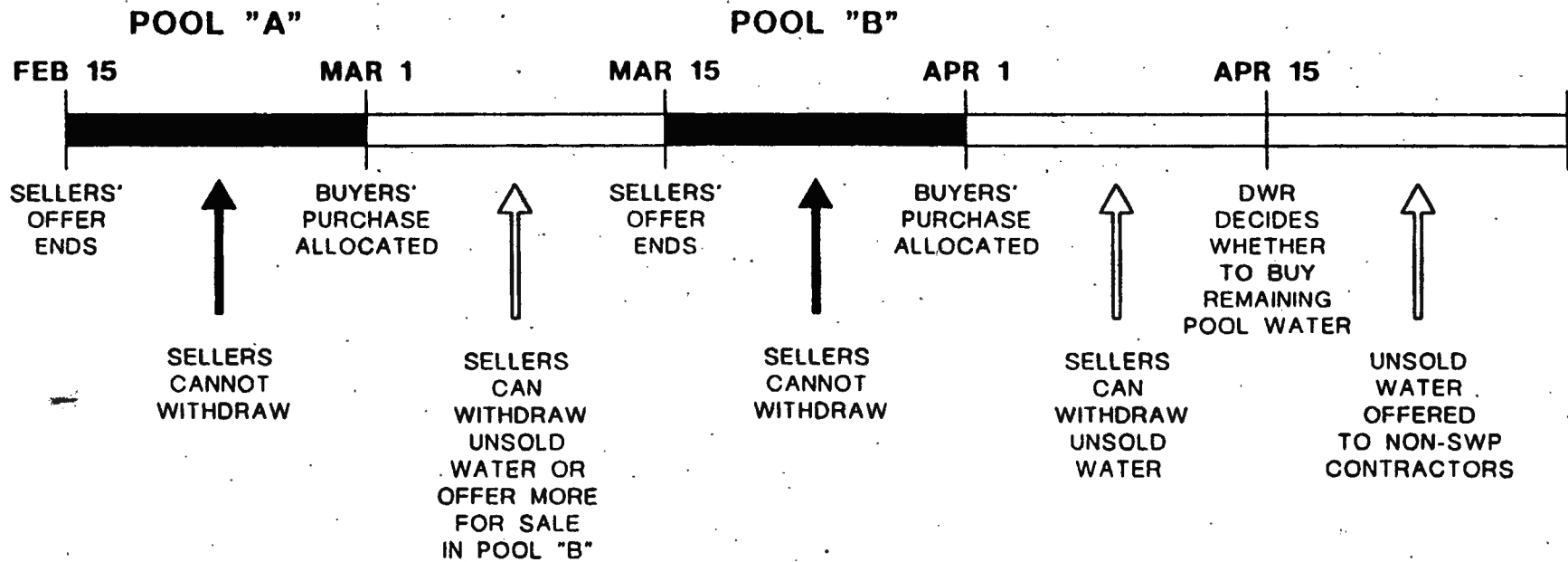

The Department of Water Resources is increasing the 1998 allocation of entitlement water for long-term State Water Project contractors from 2.41 million acre-feet to 2.95 million acre-feet. Based on the February 1, 1998 SWP reservoir storage amounts and snow survey data, SWP supplies are projected to meet 80 percent of most SWP contractors' Table A entitlements up to their requested amount. SWP contractors' Table A entitlements for 1998 total 4.09 MAF, of which 3.34 MAF was requested. A table reflecting the new 1998 SWP allocation of entitlement water is enclosed.

The Department is allocating water to users as soon as feasible to help contractors plan their operations for 1998. The Department's new approval considered several factors, including existing storage in SWP conservation reservoirs, a conservative projection of hydrology and water supply for the remainder of the 1998 calendar year, SWP operational constraints, and 1998 contractor demands. As the year's hydrologic and water supply conditions continue to develop, revised allocations may be made.

The Department of Water Resources is increasing the 1998 Entitlement Allocation to 3.19 million acre-feet for long-term State Water Project contractors. SWP supplies are now projected to meet 100 percent of all SWP contractors' Table A entitlement requests. A table showing this increased 1998 SWP allocation of entitlement water is enclosed.

The Department is allocating water to users as soon as feasible to help contractors plan their operations for 1998. The Department's new approval considered numerous factors: existing storage in SWP conservation reservoirs; a conservative projection of hydrology and water supply for the remainder of the 1998 calendar year based on the March 1, 1998 snow survey; SWP operational constraints, including an assumed completion date of May 15, 1998 for ongoing emergency repairs of the California Aqueduct; an assumed approval from the State Water Resources Control Board for pumping SWP water at Tracy Pumping Plant during the emergency outage; and 1998 contractor demands and maximum contractual delivery rates. SWP contractors' Table A for 1998 totals 4.09 MAF, of which 3.19 MAF was requested as of March 10, 1998.

**CRITERIA FOR BULLETIN 132-98
PROJECT OPERATIONS STUDIES**

1. **Water Deliveries.** Water demands for the water operation studies will be based on the short-range, five-year (1998-2002) requests submitted by the contractors in October 1997, and the long-range (2003-2035) requests submitted by the water contractors in October 1997.

2. **Water Supply.** The water and power studies will reflect compliance with 1995 modification of SWRCB Decision 1485 (June 8, 1995, order 95-6), long-term NMFS Winter Run Biological Opinion as amended on May 17, 1995, and the long-term USFWS Delta Smelt Biological Opinion dated March 6, 1995. The water supply assumed for water and power operation studies will be as follows:
 - (a) **1998**--The initial operations study for 1998 will assume hydrology sufficient to deliver 3.3 MAF (includes 0.19 MAF of "sellers water" to be stored in San Luis Reservoir and made available for later delivery to buyers and provides for 0.24 MAF of 1998-99 extended carryover water). Projections of power generation at Oroville will be based on the Oroville Reservoir inflow from the same hydrology. For generation at Pine Flat Reservoir, lower quartile inflow will be assumed. The 1998 water deliveries and water and power operations studies will be reviewed and finalized in March 1998 when the water supply forecast based on March 1, 1998 snow surveys becomes available.
 - (b) **1999**--State Water Project operations projected for 1999 are the basis for the 1999 Statements of Charges. The study will assume hydrology sufficient to deliver 3.5 MAF (contractor's projected entitlement requests). Lower quartile inflow will be assumed for Pine Flat generating facilities.
 - (c) **2000**--The 2000 studies will assume hydrology sufficient to deliver 3.6 MAF (contractor's projected entitlement requests). Lower quartile inflow will be assumed for Pine Flat generating facilities.
 - (d) **2001**--Assume hydrology sufficient to deliver contractor's projected entitlement requests of 3.6 MAF.
 - (e) **2002**--Assume hydrology sufficient to deliver contractor's projected entitlement requests of 3.4 MAF.
 - (f) **2003**--and thereafter--Assume hydrology sufficient to deliver contractor's projected entitlement requests of 4.2 MAF.

include a review of all options for fixing the Delta. In the meantime, the Department is suspending independent planning for North Delta facilities, which included channel dredging, levee improvements, testing of fish protective measures, wildlife and fisheries habitat enhancement, and enlargement of the Delta Cross Channel.

- (d) Ground Water Programs. On August 9, 1996, ownership of the Kern Fan Element Property and the La Hacienda Facilities was transferred to the Kern County Water Agency and Dudley Ridge Water District through the Kern Water Bank Authority as part of the Monterey Amendment. Fifty percent of any project water remaining in storage from the Berrenda Mesa Demonstration Program and the La Hacienda Water Purchase Program was also transferred to KWBA. The remaining 50 percent (approximately 42,828 acre-feet) remains SWP water and is subject to provisions of a recovery agreement with KCWA. The 1997 groundwater recovery program extracted 27,755 acre-feet.
- (e) Other Project Yield. For purposes of preparing water and power studies for future years, it will be assumed that the Project will deliver full entitlement requests. Additional water supply needed to meet future delivery of requested entitlement water will be assumed to be available from development of unspecified future conservation facilities.

- 5. Power Operations. Annual energy prices in the western states' power markets have historically been highest during the on-peak hours and summer months. This pattern is currently anticipated to continue into the pending deregulated energy market. The aqueduct operation will be optimized to reduce power costs by minimizing on-peak and summer pumping within the constraints of operating criteria.

For Bulletin 132-98, forecasted SWP power operation through the study period will be based on existing power sources. Additional capacity and energy resources needed to meet power requirements will be from unspecified purchases.

In 1998 and after, projected energy deficits will be met with spot market energy purchases. The price for spot market energy for the next three years is projected to be between 21 and 30 mills per kilowatt-hour. By March 1998, the Department will conduct an energy study that will forecast annual on-peak and off-peak mills rates for 1998 and after. These mill rates will be used to determine power costs or revenues for energy purchased or sold on the open market.

The 1998 Turn-back Water Pool Program closed on April 1, 1998. Four State Water Project contractors purchased 90,300 acre-feet of the 189,120 acre-feet of water offered for sale through Pool B.

The Department of Water Resources consulted with the SWP contractors in accordance with Article 56(d)(2) of the long-term Water Supply Contracts. The Department will purchase any Pool B water not withdrawn by the selling contractors. This water will provide additional carryover storage for contractors to support 1999 water allocations. The attached copy of a letter from the State Water Contractors' General Manager documents the consultation. The cost for purchasing Pool B water was \$5.70 per acre-foot (25 percent of the Delta Water Rate).

The attached table summarizes the results of Pool A and Pool B sales and purchases. If you have any questions regarding the 1998 Turn-back Water Pool Program, please contact Donald R. 
Dear Dave:

The purpose of this letter is to request that the Department of Water Resources purchase any water remaining in Turnback Pool B on April 1, 1998, after the purchase requests of individual contractors are met, for State Water Project carryover to the 1998-99 water year. DWR staff reviewed current water supply conditions at the March 19, 1998 SWC Board of Directors meeting. Based on current DWR projections, the amount of carryover storage at San Luis Reservoir in December 1998 is expected to be relatively low for drier hydrologic conditions. For these drier conditions, turnback pool purchases would increase December 1998 carryover storage and allow an increase in the initial 1999 State Water Project allocations of about 3-4 percent.

Although there is still a relatively high probability that any purchased turnback water would be "spilled" from San Luis storage during 1999, the turnback water purchases can be considered relatively cheap insurance. As indicated by DWR staff at the March SWC Board meeting, purchase of 100,000 acre-feet likely to be available after individual contractor purchases of Turnback Pool B would add about \$0.01 per acre-foot to the Delta Water rate.

Based on the foregoing considerations, the SWC Board recommends that DWR purchase any available Turnback Pool water on April 1, 1998. The SWC Board also requested that DWR work with SWC staff to document the basis for the turnback pool purchases. If you have any questions, please call me at (916) 447-7357.

The Department of Water Resources anticipates that the State's portion of San Luis Reservoir will be full sometime during the week of November 8, 1998. Approximately 35 percent of the stored water in San Luis is (1) long-term carryover water previously requested by some contractors under Article 56(c) of the Water Supply Contracts, and (2) undelivered 1998 entitlement water which may qualify for carryover under Article 12(e) of the contracts.

This is to notify contractors with stored long-term carryover water and projected Article 12(e) carryover water that the reservoir space available for such programs will soon be needed for storing 1999 State Water Project water. These contractors should take delivery of their 1998 water for use within their service areas or for programs outside their service areas which have been approved by the Department, or they risk losing their stored water. Upon the filling of the State's portion of San Luis Reservoir, available space for carryover water will be reduced at a daily rate equivalent to the Department's theoretical ability to store additional water.

In order to administer and document SWP operations, the Department requests that in the event that reservoir space is available, any contractor wishing to carry over 12(e) water from 1998 into 1999 provide a request to Donald R. Long, Chief of the Department's State Water Project Analysis Office, by FAX at (916) 653-9628 on or before November 10, 1998. When considering the carryover of 12(e) water, be reminded that a contractor cannot store undelivered 1998 entitlement water and also sell water to the 1999 Turn-back Pool Program.

The Interruptible Water Program is in place and will remain in place as long as water is available in the Sacramento-San Joaquin Delta that is not needed for SWP entitlement deliveries or SWP operational requirements, including reservoir storage goals. This situation is anticipated to be in effect from the present until several weeks into 1999.

Representatives of the Department of Water Resources and State Water Contractors are considering possible contract amendments and administrative actions intended to clarify and modify provisions of the existing long-term Water Supply Contract that were added by the Monterey Amendment. The subjects under consideration include the following:

- guidelines for SWP contractor sponsored water storage and exchange programs;
- priorities for the delivery of SWP and non-SWP water, particularly for water offered for sale pursuant to the Monterey Amendment;
- charges for a SWP contractor's use of SWP transportation facilities in repayment reaches not previously paid for by that contractor;
- procedures for the annual SWP entitlement water pool program (Turn-back Pool); and
- mechanisms for funding requests for Water Supply Contract Table A entitlement reductions.

These proposed contract amendments and administrative changes will be implemented only if SWP contractors with at least 90 percent of Table A entitlements approve the package, and contract amendments will be implemented only for those SWP contractors that approve such changes. Draft amendments will be sent to those contractors who signed the Monterey Amendment.

The Department of Water Resources is initially approving 2.24 million acre-feet of entitlement water for long-term State Water Project contractors in 1999. SWP supplies are projected to meet at least 55 percent of most SWP contractors' Table A entitlement up to their requested amount. For SWP contractors who have signed the Monterey Amendment, this allocation is based on post-Monterey conditions. For the three SWP contractors who have not signed the Monterey Amendment, this allocation is based on pre-Monterey conditions. A table showing the initial 1999 SWP allocations of entitlement water is enclosed.

In making this allocation the Department considered existing storage in SWP conservation reservoirs, a conservative projection of hydrology and water supply expected to develop during the remainder of the 1998-99 water year, SWP operational constraints, and 1999 contractor demands. SWP contractors' Table A for 1999 totals 4.12 MAF, of which 3.42 MAF was requested. As the year's hydrologic and water supply conditions develop, a revised allocation may be made.

In December, the Department will send an approved monthly water delivery schedule, based on this initial allocation, to each long-term contractor. The monthly distribution reflected in these schedules will be in proportion to the "50 percent" delivery schedule request submitted to the Department by each contractor earlier this year.

The water supply contracts require the contractors to give Notices of Contest regarding the accuracy of Statements of Charges to the State no later than 10 days prior to the date payments are due.

While the Department of Water Resources recognizes that there are several areas that must be left open for discussion, it is the Department's intention to work with the contractors over the next year to resolve the protested items listed below. Accordingly, the contractors shall have until December 21, 1999, to file Notices of Contest and to pursue other available remedies on Statements of Charges submitted prior to that date for those contested items listed below which remain unresolved:

1. All costs incurred after January 1, 1998.
2. All charges affected by procedures for determining repayment of off-aqueduct power facilities.

In addition, the following previously protested items outlined in the State Water Contractors' letter of June 14, 1994 are open and additional Notices of Contest of these items are not necessary.

1. Source of funding for some statewide planning tasks presently charged to the water contractors.
2. Source of funding for certain programs including:
 - Delta facilities planning and evaluation
 - Delta facilities operations and maintenance
 - Bay/Delta Environmental Protection Study.
3. Those costs of the Suisun Marsh facilities which are not resolved by the Suisun Marsh Agreement.

4. Source of funding and cost of routine sediment removal activities in the San Luis Canal.
5. Project energy costs and related activities as follows:
 - All costs insofar as such costs are affected by project purpose allocations.
 - Costs associated with Reid Gardner Powerplant to the extent reimbursable expenditures remain to be audited and reviewed by the contractors.
6. Reimbursement by Los Angeles Department of Water and Power for costs of the Upper Castaic Canyon recreation Development Plan.
7. Contra Costa Canal intake relocation costs charged to the contractors.
8. Statewide benefits accruing as a result of State Water Project expenditures for certain groundwater basins other than the Kern Water Bank.
9. The beneficiaries and funding of the State Water Project future water supply program.
10. The beneficiaries and funding of the recreation planning and implementation program.
11. Those costs associated with Los Banos Grandes and Arroyo Pasajero which may be outside the scope of the water supply contract.

In addition, the long-term water supply contracts provide that any overpayment or underpayment to the State in any year by reason of error in computation or other causes shall be adjusted in the next succeeding year. Under this provision, the Department makes adjustments to the Statements of Charges without regard to time limitations. This provision applies to, but is not limited to, the findings in audit reports of Ernst & Young LLP (Independent Audit Association) and Richardson & Company (Metropolitan Water District of Southern California) for costs charged to the State Water facilities as of December 31, 1997 and the annual Statement of Charges rendered by the Department dated June 30, 1998.

Interruptible Water Program for 1999

CRITERIA

1. Contractors can take delivery of Interruptible Water in addition to presently approved amounts of 1999 entitlement water. Deliveries under this Program may result in a contractor receiving water in 1999 above Table A amounts.
2. Interruptible Water will be delivered for use within the service area of a requesting contractor for the same reasonable and beneficial uses as entitlement water.
3. Delivery of Interruptible Water shall not impact allocation or delivery of entitlement water to contractors in 1999.
4. Water available under this Program shall be State Water Project water available as determined by the Department that is not needed for fulfilling contractors' annual entitlement deliveries, as set forth in their approved water delivery schedules furnished pursuant to Article 12, or for meeting Project operational requirements, including reservoir storage goals for the current or following years.
5. Delivery may be limited by operational capacity in Project facilities or as a result of changed operational conditions.
6. Interruptible Water shall not be delivered in any way that would adversely impact any SWP operations. If the Department determines there has been an adverse impact during the period when Interruptible Water is being delivered to a contractor, Interruptible Water may be reclassified as 1999 scheduled entitlement to keep the Project whole.
7. Interruptible Water shall not be stored by the Department in Project reservoirs for later delivery to a requesting contractor.
8. This Program is not intended to allow a contractor to shift or defer delivery of allocated scheduled 1999 entitlement and substitute delivery of Interruptible Water for 1999 entitlement water in a way that would adversely impact delivery of entitlement water to other contractors in 1999 or in any subsequent year, or adversely affect Project storage of water.

SCHEDULING AND CHARGES

9. Participating contractors shall request 1999 Interruptible Water by submitting a weekly schedule to the State Water Project Analysis Office by FAX at (916) 653-9628, attention: Teresa Geimer. Schedules shall be submitted by 10 a.m. Wednesday for the following Monday through Sunday. The weekly schedule shall include a statement identifying the intended use of the Interruptible Water.
10. If necessary, the supply of Interruptible Water will be allocated among requesting contractors in proportion to the 1999 Table A entitlements of those contractors.
11. The Department may determine the availability of Interruptible Water on a daily basis and may discontinue delivery upon short notice.
12. A contractor taking delivery of Interruptible Water may stop or suspend participation in the Program by notifying Teresa Geimer at (916) 653-4635 or by FAX at (916) 653-9628.
13. Each day Interruptible Water is delivered, a participating contractor must also take daily delivery of its approved 1999 entitlement water at the following rate per month:

For Agricultural Interruptible Water use:

January 1% February - August 2% September - December 0%

For M&I Interruptible Water use:

January 2% February - August 4% September - December 0%

The Department will exempt Interruptible Water delivered to groundwater recharge and/or local storage programs from the requirement to take a minimum daily percentage of 1999 entitlement water if (1) the contractor assures the Department that entitlement deliveries are not being shifted into later delivery months as a result of receiving the Interruptible Water; and (2) the contractor submits monthly reports showing entitlement deliveries and showing the rates, times and quantities of exempt Interruptible Water being delivered to specific groundwater storage programs. The minimum percentage rates shall remain in effect for all other Interruptible Water being delivered. The Department will organize all data received from participating contractors to allow peer review of the 1999 Interruptible Program by all SWP contractors.

14. Conveyance charges for Interruptible Water delivered under this Program shall be the same as for entitlement water and shall include Transportation variable operation, maintenance, power and replacement component charges, Off-Aqueduct Power Facility charges, and any incremental OMP&R costs, as determined by the Department.

15. All contractors participating in the Program are responsible for coordinating delivery points and rates through their normal contacts at the various Department field divisions.
16. Participating contractors shall identify a contact person for the Department to notify concerning all matters under this Program.
17. The 1999 Interruptible Water Program shall not be a precedent for future programs.
